Dear Mid-Atlantic Fellows:

We are pleased to announce that nominations for Class IV of the Mid-Atlantic Fellows Institute (“MAFI”) are now open, and with your help, will be just as successful as the prior three Institutes! On a national level, the Institutes have already begun to produce young ACTEC Fellows from their graduates, including nine MAFI graduates.

As you may recall, in order for a potential participant to submit an application to the Institute, they must be nominated by an ACTEC Fellow. Fortunately, that is very easy to do: nominations may be submitted electronically by visiting <https://midatlanticfellowsinstitute.org/nominate/>. **The deadline for nominations is April 30.**

As a refresher, the concept is that MAFI (and other ACTEC Institutes across the country) is a program to help develop the profession’s future leaders in trust and estate law through a series of in-depth educational presentations led by outstanding subject matter experts in each field. “Students” are both in private practice and at trust companies.

Our goal is to find attorneys (particularly “up and comers” – ideally with three to seven years of focused practice in the trusts and estates field) whom you believe would be good nominees for our fourth class; they do not need to be qualified to be nominated as ACTEC Fellows. As before, candidates may come from Delaware, Maryland, New Jersey, New York, Pennsylvania and Washington, D.C. and must be in good standing with the Bar Association in one of the region’s states. Each of the six Mid-Atlantic jurisdictions has had great representation in the prior classes and we hope to be able to have similar geographic diversity for Class IV.

As a reminder, participants must successfully complete all six programs (three, two-day sessions) to be recognized as Graduates. The schedule for MAFI Class IV is as follows:

**Session I:** October 17 & 18, 2024 – Wilmington, DE

**Session II:** February 6 & 7, 2025 – Baltimore, MD

**Session III:** April 24 & 25, 2025 – Princeton, NJ

Please mark your calendars for these dates so that you can join us during networking opportunities including Thursday evening cocktail receptions (October 17, 2024, and February 6 and April 24, 2025).

Tuition for Class IV is \$3,600 per student, which includes all programs, breakfast and lunch during each session, a dinner with cocktail reception, and website access to course materials.
